What type of government do we live under?

Due to the uncertainty in our knowledge of this subject, I have endeavored to present this information in basic concepts and language. What the reader is about to hear is only whispered by others, for if it were publicly announced by our government officials it would rock the world. Our question is "what type of government have we today?" Many will have answers but are they right?

To begin our inquest for the answer we must start long ago, to the year 1863 and understand that what we call a *republic* type of government was overthrown 1863, at which time we were introduced to *Lincoln's democracy*.

So what does that mean to us? In a <u>republic</u>, citizen's rights are guaranteed by its government which is controlled by the people. In a democracy, the people are not the rulers any longer and no longer sovereign. We the people become serfs' of congress and elites who think they own 'we the people.'

Our country's status changed from a *non-debtor Republic* to a *debtor democracy*, where the people are now considered to be the *obligated debtors*. As a debtor we are presumed to be owned by the creditor (owners) of the nation, which we know as the international banking elite and others associated with them. In fact our representatives have evolved to become representatives of these elite creditor/owners to manipulate our minds and laws.

A whole new world and system of law has been created by our owner elite and in order for it to work it is necessary that we be subservient to them. This is accomplished through contracts we enter voluntarily! So the experiment with America's government failed its people by failure of the people to hold on to the prize, *a republic*.

We will not find the word "democracy" in our constitution of the state or the central government (united States of America). *Democracy* was the form of government implemented by the *creditor elite* who has been working to control the world through the medium money (or more correctly, *currency*), of *finance and trade* throughout the world. This democracy adopted all the traits of the old English *feudalistic* system where the King was has been substituted with a corporation with an executive (a **president**) and a board of directors (**cabinet** of advisors).

In the transition from <u>republic</u> to <u>democracy</u>, Congress has become a make believe representatives of the people, and the judicial branch began administering the bankruptcy of the United States and no longer politically independent. The courts are now a servant to the bankrupt U.S. legislative democracy and the people are now viewed as surfs of the British Controlled U.S. Corporation we know as "the United States" by federal statutory law, title 28 USCA section 3002 (15)A,B,C.

Now, what caused our Republic to turn into a democracy? WE CAUSED IT! We ignorantly, or apathetically, accepted change without knowing what we were changing into. In other words we and our ancestors were deliberately made stupid by a public school system where the curriculum is controlled by the *creditor elite*! We gave up sovereign status for a corporation (a legal fiction) controlled by our creditors and we became the obligated debtors. Therefore, we can now understand we live under a (legal fiction) democracy and have become work slaves, very similar to the control Rome exercised over its people. We now live under foreign laws (laws of Great Britain) as a captured and indebted people. Our American constitutions were designed for free people not for captive debtor.

So, Abraham Lincoln gave this country, by design, a new form of government called a "*democracy*" where the legislative U.S. Congress

and Executive of <u>the democracy</u> would rule us as a subservient federal work slave citizen (via a Social Security account... a contract).

Title 28: Part V: Chapter 115: § 1746.

Unsworn declarations under penalty of per-jury

Title 28 1746 (§ 1) united States of America

and Section (§ 2) United States

Wherever, under any law of the United States or under any rule, regulation, order, or requirement made pursuant to law, any matter is required or permitted to be supported, evidenced, established, or proved by the sworn declaration, verification, certificate, statement, oath, or affidavit, in writing of the person making the same (other than a deposition, or an oath of office, or an oath required to be taken before a specified official other than a notary public), such matter may, with like force and effect, be supported, evidenced, established, or proved by the unsworn declaration, certificate, verification, or statement, in writing of such person which is subscribed by him, as true under penalty of perjury, and dated, in substantially the following form:

- (1) If executed without the United States: "I declare (or certify, verify, or state) under penalty of perjury under the laws of the United States of America that the foregoing is true and correct. Executed on (date). (Signature)".
- (2) If executed within the United States, its territories, possessions, or commonwealths: "I declare (or certify, verify, or state) under penalty of perjury that the foregoing is true and correct. Executed on (date). (Signature)".

You will notice that Title 28, Chapter 115, Section 1746 provides for the *subscription* of a statement *within* (inside of) and *without* (outside of) "the United States." "Within" means inside "the [corporate] United States" and "without" means outside the [corporate] United States. The republic of the united States of America is *outside* "the [corporate] United States."

Therefore, title 28 sections, chapter 115, section 1746-1 allows us to understand that we live in the united states of America, a Republic and not the territories of "the [corporate] United States," a legislative democracy identified in section 1746-2.

So, allow me to point out that the experiment with a republic is over and the experiment with democracy is over also. So what is left? *Martial law rule* is left, for that is the law behind our civil law democracy (our current form of government) from 1863 to the present (2010). Because Lincoln illegally declared *martial law* which has never been rescinded, our *economic civil war* continues from Lincoln's time through to today. States rights v. central governments rights. Remember democracy has never lasted as a government, only a dictatorship or Oligarchies have.

Our 10th Amendment to the constitution was designed for a people who were not obligated debtors, therefore, how are debtors going to claim change? Only *their owner* can make the change and they [the creditor elite] are busy making profits on their slave citizens who live in *federal territorial states* [municipal corporate STATE OF YOUNAMEIT] under District of Columbia municipal corporate private law called "Martial law rule".
