As we begin, any reference to "people" or "peoples" is a reference to "we the people" as that term is used in the constitution for the republic of the united States of America.

Are we living in the Republic created by "we the people" back in the late 1770's? Do we care? Are we really free? Historical facts continue to be kept from our education, public & private. Therefore, if someone were to tell us, "there are two different "United States", I would politely inform them that there are three!

In <u>Hooven and Allison Co v. Evatt</u>, 324 U.S. 652 (1945), history shows us our ancestors were freer in the Republic than in the current **corporate** Democracy.

So what happened? Our original (de jure) Republic lasted from 1774 to 1861, some 87 years under the Article of Confederation and the constitution for the republic of the united States of America. In this Republic, Americans used biblical law from the King James Bible, American *common law*, *not English common law*.

Our Republic started with "the people's juries' and a sheriff at the county level" as the Peoples supreme law enforcers. See also the 10th amendment! From the counties we organized states, then our Continental united states of America. Our representatives from the states and its people formed a continental congress with judicial officers, and executive officers, to supervise **interstate commerce** and **foreign international commerce/relations**. The people as jurors' could rule on both the facts <u>and law</u> of a case. If the law & facts were not applicable, the people in their capacity as jurors could deny, or set aside, the case through a "not guilt" verdict. In today's world, the jury is given instructions by the judge (government) which they tend to follow like the dutiful *rubber* stamps that they have become.

So, in court, the people had the **last say** as to what law is applicable and how the law in a particular case is applied. This is the peoples jury, the 7^{th} amendment. No government official, nor State or central government could overrule the people's verdicts. This is truly what is meant by government of the "we the people."

This Republic of & by the people was an <u>experiment</u> and one of our founding fathers (Benjamin Franklin I believe) was quoted as saying "<u>We have given you a republic if you can keep it</u>".

Have we be able to keep it? Are we, today, experiencing our Republic form of government? "<u>NO WE ARE NOT!</u>" Very powerful forces in the world did not like, and continue to dislike, this experiment in a Peoples Republic and wanted secretly to convert the government back to a form of feudalistic European control. So the wealthy elite (the international investors) secretly and stealthily acted to change our Republic by wars that pitted the States & peoples against themselves, the North against the South.

The reality of the Civil War is that the issues were not of slavery as we are taught in today's schools, but were instead the issue of <u>unalienable</u> <u>rights</u> vs. <u>the elite's control over a government that in turn controls the</u> <u>corporate privileges of all persons</u>.

Had the southern states won the war, our unalienable rights would not have a competitor called *rulers' privileges' civil law*, which was being supported by the northern states **regime**. The Int'l elite had influenced our continental government legislators from 1820 to 1861 to overthrow the de jure Peoples' Republic and reunite the Northern States with European elite rulers. Thus the European elite backed both sides of the civil war and then stopped financing the south while keeping the North supplied with money and war materials. This was to become a reason why the Russian Czar offered to protect the Southern Confederate States of America with his ships to stop British war ships blockade on Southern States sea ports. The Czar was evidently aware of the *elites* plan & plot to ruin our Peoples Republic. Since the same *elites* financed the Bolshevik revolution in Russia, the Czar descendants were ultimately murdered in that revolution of 1917.

As the Civil War began in 1861, Lincoln declared <u>a state of emergency</u> found in our de jure constitution. Lincoln's declared marshal law, utilizing federal troops under the "**law of necessity**", causing our Peoples' public **institutions to be** ruled by unseen military authority.

Therefore, from 1871 to 1933 we had two competing system of government as confirmed by the Supreme Court decision in the "separate but equal case <u>Plessy v. Fergusion, 347 U.S. 483, (1896)"</u>. The world elite in 1933, now had to change the peoples political relations from a Republic to a military martial law rule. Consequently a **Fascist** Democracy form of government, were the American people would by <u>silent consent</u> contract and vote for a military federal rule and become a <u>federal citizen</u> called a <u>U.S. citizen</u> under the war time 14th Amendment.

Most of our ancestor and fellow countrymen did this by *voluntary* silent consent for a form of government called a [fascist] Democracy.

Democracy was never a form of government, check your history.
